MINUTES OF THE ANNUAL MEETING OF THE PARISH COUNCIL HELD ON MONDAY, 12TH MAY 2014 at 7.30pm IN THE ELLIS ROOM, LANGTON GREEN VILLAGE HALL

14/104 ELECTION OF CHAIRMAN: RESOLVED to elect Cllr Mrs Jeffreys as Chairman of the Parish Council. She signed the declaration of office which was counter-signed by the proper officer.

14/105 ELECTION OF VICE-CHAIRMAN: RESOLVED to elect Cllr Milner as Vice-Chairman of the Parish Council. He signed the declaration of office which was counter-signed by the proper officer.

14/106 APOLOGIES FOR ABSENCE: Cllr Woodward (prior engagement)

14/107 DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTERESTS: There were none.

14/108 DECLARATIONS OF LOBBYING: Cllr Mrs Hull declared that she had been spoken to about highways issues; Cllr Mrs Horne declared she had been spoken to about Speldhurst Recreation Ground playground and Cllr Langridge declared he had been spoken to about the Treetops Planning Appeal.

14/109 MINUTES: RESOLVED that the Minutes of the Full Council Meeting held on **7**th **April 2014** were approved as a correct record and signed by the Chairman.

14/110 CO-OPTION OF COUNCILLOR: Mr Barrington-Johnson was requested to leave the room while the recommendation of the panel was discussed. It was **RESOLVED** to co-opt Neil Barrington-Johnson as a Parish Councillor and he re-joined the meeting. He signed the declaration of office which was countersigned by the proper officer.

14/111 BOROUGH AND COUNTY COUNCILLORS REPORTS: Borough Councillor David Jukes reported that he now has a programme for the demolition of the old cinema site. He also reported that he attended a Kent Leaders' meeting regarding the proposal for a second runway at Gatwick which the majority favoured. He, along with

three other members, had voted against the Gatwick proposal and recommended the plan for an airport in the Thames estuary.

14/112 PUBLIC OPEN SESSION: There were no members of the public present.

14/114 APPROVAL OF ANNUAL RETURN: Cllr Pendleton reported that the Governance Committee had studied the Annual Return and found everything to be in order. It was **RESOLVED** that Cllr Mrs Jeffreys and the Clerk sign pages 2 & 3 of the Annual Return and it be sent to the external auditor.

14/115 FINANCE COMMITTEE - Report by Cllr Owen

- i) A Committee meeting was held on 24th April and the minutes have been circulated.
- ii) It was **RESOLVED** to approve the following budget virements; £1,080 from Contingency to Langton Green maintenance for the increase in the Groundsman's hours, which was approved after the budget was set and £1,000 from Langton Green Play Area to Langton Green Maintenance as the Groundsman now carries out all the playground inspections and this is paid for out of Langton Green Maintenance.
- iii) It was **RESOLVED** to accept the recommendation of the Finance Committee and grant £4,000 to St Mary's Church, Speldhurst towards vegetation clearance and new fencing.
- iv) After considerable discussion and a vote of 11:1 in favour it was **RESOLVED** in principle to agree to the Speldhurst Recreation Ground's request that the grant already pledged be used for a variation to the design of the new playground. **The Clerk will ask the Chairman of the committee to attend the next Full Council meeting to explain the revised proposal in more detail.**
- v) It was **RESOLVED** to contribute £440 to the TWBC Fun Days to be held at Langton Green and Speldhurst Recreation Grounds in the summer holidays. **The Clerk was asked to advise the organisers of the SE Water works which may affect attendance.**

14/117 HIGHWAYS:

- a) Cllr Mrs Podbury reported that TWBC is promoting 20mph speed limits outside schools, there have been several accidents in the parish recently and that Speldhurst Road, Langton Green will be closed during the school summer holiday for South East Water works.
- b) The consultation period for the proposal for double yellow lines outside the butcher's shop on Langton Road has now closed. Borough Councillor David Jukes suggested that consideration is given to a counterproposal by the Highways Committee.

14/118 COMMUNITY RIGHT TO BID: The Clerk reported that the nomination of the land adjoining Treetops, Stonewall Park Road is being considered by TWBC. Cllr Langridge reported that an ecological survey was not carried out as the owner would not permit access.

14/119 LANGTON GREEN SPORTS CLUB: The Langton Green Sports Club had requested that some of the expenditure KCC will be making on the car park improvements be transferred to the pavilion project. It was unanimously **RESOLVED** not to accede to this request.

14/120 LANGTON GREEN RECREATION GROUND:

- a) It was **RESOLVED** to grant permission to The Rude Mechanical Theatre Company to use the Recreation Ground on Wednesday 25th June for their outdoor theatre.
- b) It was **RESOLVED** to grant permission to Langton Green Cricket Club to display two signs; one by the gate from the car park onto the recreation ground and one on the pavilion, advertising for new members.

14/122 SPELDHURST SCOUTS: A suitable project for the Scouts to commemorate Community Day on 6th June was discussed and it was agreed that tidying fallen timber in Shadwell Woods would be a good idea. **Clir Milner and Clir Mrs Horne will liaise with the Scouts.**

14/123 TO RESPOND TO A LETTER FROM MR GREENSLADE REGARDING THE COUNCIL'S POSITION ON GATWICK EXPANSION: Cllr Mrs Soyke had drafted a reply which had been circulated to all Councillors. It was **RESOLVED** that she should send this to Mr Greenslade on behalf of the Council.

14/124 CHAIRMAN'S REPORT: Cllr Mrs Jeffreys reported that there was a good attendance at the Annual Parish Assembly and thanked all those who had been involved with the organisation. A small working group would now be formed to prepare for next year's event.

14/125 COMMITTEE REPORTS:

- i) **Governance** –Cllr Pendleton reported that a Committee meeting was held on 30th April and that the minutes have been circulated. It was **RESOLVED** to approve the annual review of the Internal Financial Control System and an amendment to the Grant Awarding Guidelines.
- ii) Planning Cllr Langridge reported that there had been two Committee meetings since the last Full Council meeting which were held on 8th April and 8th May and that both minutes have been circulated. He reported that there is a hearing at TWBC on 20th May in connection with the planning appeal on land in the quarry adjacent to Treetops, Stonewall Park Road, Langton Green. The next Committee meeting will be held on 9th June.
- iii) Amenities Cllr Milner reported that the next Committee meeting is on 19th May.
- iv) Air Traffic Cllr Mrs Soyke said there had been no meeting since the last Full Council and referred to her report.
- v) Footpaths Cllr Milner reported that he is seeking confirmation from KCC PROW as to when they will replace the bridge in Shadwell Woods. Cllr Milner and Cllr Langridge have compiled a list of footpaths in Langton Green to be cut and cleared by the Groundsman and funded by the grant given by the Langton Green Rural Society. South East Water has carried out works in Pocket Park and it has not been reinstated satisfactorily. Cllr Milner has been asked by residents if Roopers can be mowed because it is overgrown.
- vi) **Broadband** There was nothing to report.
- vii) **KALC** There was nothing to report.
- viii) **Parish Plan Working Group** Cllr Turner reported that James Bowdidge is now Chairman of the working group and that they still need more volunteers to join. He was concerned that the working group was losing momentum.
- ix) **Environment Working Group** There was nothing to report.
- x) **First World War Working Group** Cllr Langridge reported that he is speaking to Langton Green Brownies next week about the First World War.
