# 18/00385/FULL

Location: Garage Block and Land, Lampington Row, Langton Green, Royal Tunbridge Wells, Kent Proposal: Demolition of existing garages and erection of 2 no. dwellings with 6 no. parking spaces. Decision: Objection: whilst we understand the need for affordable housing there is a serious parking problem already in this road and neighbouring roads given the recent expansion of the Primary School. This proposal significantly reduces the number of parking spaces/garages available to residents. It is particularly unhelpful that the parking survey indicated availability in Winstone Scott Avenue (which already has parking issues) and ignores the impact of school traffic.

#### 18/00403/TPO

Location: 12 Roopers Speldhurst Royal Tunbridge Wells TN3 OQL

Proposal: Trees: Sycamore (T40) - Crown lifted to first major fork; Ash - Reduced and balanced and pruned back from yew tree garden side, top of tree to have crown thinned to improve shape; Adjacent sycamore taken down to ground level to improve shape, growth and spread of ash tree listed above; Sycamore to be taken down to ground level to improve growth of adjacent sycamore.
