Proposal: Tree in a Conservation Area Notification – Spruce (T1) – Remove, Willow (T2) – reduce to

a pollard; 5 x Silver Birch (G1) – Remove.

Decision: Remain neutral, leave to Tree Officer.

23/02605/TPO - Tree Tops, Stonewall Park Road, Langton Green

Proposal: Trees: 8 No. Ash; Oak; 2 No. Sycamore – Top all trees approximately 5 metres.

Decision: Remain neutral, leave to Tree Officer.

23/02606/TPO – White Moore, Stonewall Park Road, Langton Green

Proposal: Trees: Birch (T1); Sycamore (T2); Cherry (T3) – Reduce and shape by approximately one

third by 3-4 metres.

Decision: Remain neutral, leave to Tree Officer.

23/02555/FULL – Tamerton House, Furzefield Avenue, Speldhurst

Proposal: Proposed single storey rear extension, blocking and relocation of windows on first floor

and internal reconfigurations.

Decision: Remain neutral, leave to Planning Officer.

23/02513/TPO - Kirby Court, Long Slip, Langton Green

Proposal: Trees: Ash (T1) – Section fell to ground level.

Decision: Remain neutral, leave to Tree Officer.

23/02503/LBC – Etherton Lawn, Stockland Green Road, Speldhurst

Proposal: Listed Building consent – Conversion of existing garden store to residential annexe

including alterations to fenestration.

Decision: Remain neutral, leave to Conservation Officer.

Proposal: Replacement weatherboarding to elevations along with low level render finish. Adjust existing West Election door and window openings. Replace existing rear dormer to garage roof. Fit 2 rooflights to front slope of garage roof and 3 rooflights to rear slope.

Decision: Remain neutral, leave to Planning Officer.

Proposal: Conversion of existing garden store to residential annexe including alterations to

fenestration.

Proposal: Rear and side extension, loft conversion with rear dormer and rooflights and changes to

fenestration.

Proposal: Detached new dwelling and garage. Associated hard and soft landscaping. Vehicular driveway.

Decision: We Remain neutral, however there are some specific points raised by neighbours which we would like the planning officer to take account of. We note that the design appears to be of a high quality.

Proposal: Replacement of front hedge with boundary walls, gate and railings.

Decision: Remain neutral, leave to Planning Officer.

Proposal: Replacement 1.8m fencing along garden boundary spanning 20 metres.

Decision: Remain neutral, subject to the points raised by KCC Highways.

23/02419/FULL - Ashurst Place, Lampington Row, Langton Green

Proposal: Variation of Condition 2 of Planning Permission 21/02886/FULL – Amendments to the original landscape plan to allow for sufficient landscape and environmental enhancements to accord with original PEA and Proposed LEMP.

Decision: Remain neutral, leave to Planning Officer.

23/01006/FULL – 29 Northfields, Speldhurst

Proposal: Conversion of garage into office space with new fenestration and door, extension of existing driveway.

Decision: Remain neutral, leave to Planning Officer.

23/02384/LAWPRO - 24 Dornden Drive, Langton Green

Proposal: Lawful Development Certificate (Proposed) Extension to the area of existing driveway in the front garden and new timber finish vehicular and pedestrian gates.

Decision: Remain neutral, leave to Planning Officer.
