## 8. Public Open Session

There were two members of the public present to discuss application 25/00917/FULL for Ashurst Place: Aidan Webb – local resident and Director of Spider Projects and Mike Salter of PMMR Developments Ltd.

Mr Webb explained that after some initial problems with ecology, the project was now slowly under way. Spider Projects came on board six months ago and after carrying out a review, further recommendations have been made to improve health and safety aspects of the building which he explained should take precedence. Ashurst Place is not Listed but a Non-Designated Heritage Asset.

### 10. Planning Applications for consideration

## 25/00917/FULL – Ashurst Place, Lampington Row, Langton Green

**Proposal:** Variation of Condition 2 of Planning Permission 21/02886/FULL - changes to internal layout; alterations to fenestration on north, west and south elevations; vertical metal railings added to terrace parapet on north elevation; reconfiguration of glazed roof lantern and addition of rooflight.

**Design:** Remain neutral: Having reviewed the plans in detail, we have no concerns with the changes proposed to the existing consent.

#### 25/01064/TPO – Land at Broom Park, Broom Park, Langton Green

**Proposal:** TREES: LEYLANDII (T1) - Remove snapped out limb; 2no. LEYLANDI (G2) - Fell to ground level; LEYLANDI (T3) - Reduce height by 12m; LAWSON (T4) - Fell to a 3m stick and leave as standing deadwood; FIR (T5) - Dismantle entire tree to near ground level.

**Decision:** We appreciate the photos provided in this application and offer no comments, defer to the Tree Officer.

### 25/00919/FULL - Rivendell, Claytons Lane, Ashurst

**Proposal:** Timber orangery to replace existing structure.

**Decision:** Support: This looks to be a visual amenity upgrade to the existing and we support this application. We appreciate the quality of the application and supporting materials.

# 25/00824/FULL – Perugia, Ewehurst Lane, Speldhurst

**Proposal:** Erection of detached single storey annexe building to replace existing. **Decision:** Remain neutral: We are content with the reduction in scale compared to the prior application and are pleased to see a high-quality application.

#### 25/00889/TPO – Keibara House, Stonewall Park Road, Langton Green

**Proposal:** Trees: Cypress – FELL.

**Decision:** Oppose: There is no accompanying information to support this felling of a protected tree. A single sentence without attribution is not suitable information to support. We would propose that a reduction to the canopy would be more appropriate. If granted, we request a replacement tree be planted in lieu of this TPO protected tree being removed.

# 25/00846/FULL - Long Acre, Ferbies, Speldhurst

**Proposal:** Variation of Condition 2 of Planning Permission 24/02804/FULL- (Changes to front elevation fenestration to two-storey extension).

**Decision:** Support: We consider these alterations to the approved plans to provide better visual amenity.

# 25/00521/FULL - Silcocks Farm, Poundsbridge Lane, Fordcombe

**Proposal:** Alterations to existing access.

**Decision:** Remain neutral: This is largely a Kent County Council Highways decision who have already reviewed the case. As long as the visibility splays remain safe, we have no comment.
