#### 8. Planning Applications for consideration

25/00656/FULL and 25/00657/LBC – Fountain Cottage, Groombridge Hill, Groombridge
 Proposal: First floor rear extension, reconfiguration and removal of internal structures, demolition of existing conservatory, addition of bay window and two rooflights.
 Decision: Remain neutral, leave to Planning and Conservation Officers.
 Cllr Norton was concerned regarding previous issues with an overflowing septic tank and the Assistant Clerk was asked to email the Planning Officer responsible for this application to draw the matter to their attention.

# 25/00613/TPO - 2 Roopers, Speldhurst

**Proposal:** Trees: Oak (T1) – Reduction of approx. 3m and raise crown to approx. 5m. **Decision:** We support this application and would like it on record that Speldhurst Parish Council is the applicant.

# 25/00597/FULL – 10 Great Courtlands, Langton Green

**Proposal:** Demolition of the garage and conservatory. Part single storey part two-storey side, front and rear extension.

**Decision:** Remain neutral, leave to Planning Officer.

# 25/00596/FULL – Willow Tree Cottage, Franks Hollow Road, Speldhurst

**Proposal:** Demolition of existing conservatory; construction of single storey front and rear extensions.

Decision: Remain neutral, leave to Planning Officer.

#### 25/00566/TPO – 6 Roopers, Speldhurst

**Proposal:** Trees: Oak (T1) – Reduce lowest limb by 2m. **Decision:** Remain neutral, leave to Tree Officer.

#### 25/00553/TPO – The Boundary, Langton Green

**Proposal:** Birch (T1) crown lift up to approx. 2.4m; Alder (T2) crown lift up to approx. 2.4m.

**Decision:** We support this application and would like it on record that Speldhurst Parish Council is the applicant.

# 25/00152/LBC – 4 Stone Cottages, Groombridge Hill, Groombridge

**Proposal:** Listed Building Consent (works commenced) Installation of rooflight and internal works.

**Decision:** This application cannot proceed to a decision because many of the questions on the application have not been answered and the information provided is very minimal.

#### 25/00815/LBC – 4 Stone Cottages, Groombridge Hill, Groombridge

**Proposal:** Listed Building Consent – removal of internal wall (works carried out). **Decision:** This application cannot proceed to a decision because many of the questions on the application have not been answered and the information provided is very minimal.

#### 25/00837/TCA – Wechylstone, Langton Road, Speldhurst

**Proposal:** Trees in a Conservation Area Notification: Holly (T1) – Fell; 2 no. Sycamore (T2, T3) – Fell.

Decision: Remain neutral, leave to Tree Officer.

# 25/00756/FULL – Land to the Rear of the Black and White Shop, The Green, Groombridge

Proposal: Variation of condition 2 and removal of condition 4 of 20/02381/FULL – Amendments to fenestration and removal of obscure glass in NE elevation.
 Decision: We object to this application on the basis that we think that the original condition should be upheld, and the obscured glass should remain. There is no guarantee that the fence will remain in place.

# 25/00723/FULL – 2 Newlands, Langton Green

**Proposal:** Proposed single storey rear extension and extension to front elevation dormer window.

**Decision:** Remain neutral, leave to Planning Officer.

#### 25/00730/TCA – Court Lodge, Groombridge Road, Groombridge

**Proposal:** Trees in a Conservation Area Notification: Holly (T1) – Dismantle to approx. 5m.

Decision: Remain neutral, leave to Tree Officer.

#### 25/00692/TPO – 44 Dornden Drive, Langton Green

**Proposal:** Trees: ASH – reduce height to approx. 10m. **Decision:** Remain neutral, leave to Tree Officer.

# 25/00678/FULL – Conifers, Stonewall Park Road, Langton Green

**Proposal:** Garage conversion to habitable accommodation and ground floor rear elevation door alteration.

Decision: Remain neutral, leave to Planning Officer.

#### 25/00820/FULL – 15 Upper Profit, Langton Green

**Proposal:** Rear and side two, part first floor and single storey extensions and porch extension.

Decision: Remain neutral, leave to Planning Officer.
