#### FOOTPATHS - a major problem

Everyone will have noticed that the long spell of dry weather earlier in the year has been followed by one of the wettest May and June on record. The result has been that nettles, weeds and brambles have got out of control. In the past, Kent Highway Services have maintained these footpaths but after extensive cuts were made to the Council's Countryside Access Service budget, work has been seriously reduced and despite the best endeavours of volunteers to keep these footpaths open, they cannot manage it on their own. WE ARE THEREFORE MAKING A POLITE REQUEST. For those residents who own a property which has a footpath running past it, we would ask you to take responsibility for keeping that section of the footpath clear. According to Kent County Council, there is an obligation upon landowners to do so and in this way, you will help us to keep your path



open, which will be to everyone's benefit. If you are aware of any problems but are unable to help, please get in touch with the Parish Clerk.

## Local needs housing

Speldhurst Parish Council has been advised by English Rural Housing Association that they are postponing their involvement in the Speldhurst Local Needs Housing project. Due to recent changes in the funding requirements of their lenders, the Speldhurst scheme no longer complies with the financial parameters set by their board. They do not envisage the funding environment improving markedly during the lifetime of this government. The Parish Council will be having discussions with Tunbridge Wells Borough Council in July about the future of the Local Needs Housing Scheme.

## Broadband - an update

We are still expecting, with the help of Kent County Council funding, to see improvements to services for many Langton Green residents in 2013, but most effort by the Broadband Working Group is currently addressing the harder-to-reach rural parts of the Parish. In this respect, we were very pleased to see our application for possible DEFRA funding endorsed in March of this year. We are now putting together our final application for DEFRA funds, submission being due by the end of September. Though led by the Parish Council, the Working Group includes six residents of the Parish and this initiative now involves six neighbouring parishes and is being actively supported by TWBC and Sevenoaks District Council.

### Traffic restrictions being introduced

Following a spate of accidents in recent years at the 'S' bend in Stone Cross, measures will shortly be put in place to slow traffic, not just on the bends, but also on the stretch from Langton Green to Ashurst where a 50mph speed limit is being introduced. All the surveys have been carried out, funding has been found – mostly coming via our Kent County Council Councillor's Member Fund, and installation should take place in the very near future. A restriction on Groombridge Hill is also being introduced – the Parish Council are just waiting for the signage to be put in place.
