**Proposal:** Extension to driveway and construction of outbuilding.

**Proposal:** Trees in a Conservation Area Notification: Leyland Cypress x 8 (G1) – reduce by

6-8 meters.

#### 25/00046/FULL – 24 Salisbury Road, Langton Green

**Proposal:** Partial demolition of existing rear extension; addition of new single storey rear extension; shanges to fonestration

extension; changes to fenestration.

**Decision:** Remain neutral, leave to Planning Officer. We note the high-quality of this

submission.

# 24/03255/FULL – 19 Holmewood Ridge, Langton Green

15m; 5 No. Sycamore (G4-G5) – reduction to 15m. **Decision:** Remain neutral, leave to Tree Officer.

- Date of next Planning Committee meeting: Monday 17<sup>th</sup> March 2025, Palmer Room, LGVH. Cllr Norton gave his apologies for this meeting.
- Groombridge Place planning application, report by Cllr Norton: Concerns had been
  raised regarding the feedback from the Tunbridge Wells Borough Council (TWBC)
  Conservation Officer on The Pig's proposals for the site and it was hoped that
  agreement could be reached between the parties involved to ensure that the
  development proceeds. Borough Cllr Sankey had written to the Conservation Officer
  expressing these concerns and outlining how disastrous it would be for the parish if

The Pig withdrew from the project. It was agreed that Cllr Norton would draft a letter to be sent to the Conservation Officer from Cllr Curry as Speldhurst Parish Council (SPC) Chair and Cllr Cleaver as Planning Committee Chair expressing the concerns on behalf of the parish.

- Burrswood, Groombridge, update by Cllr Norton: A meeting was being held in February between the owner of Burrswood and the TWBC planners. Cllr Norton had been led to believe that once the proposals had been firmed up, the owner would be in a position to talk to residents regarding his plans.
- LGCSA's planning application for a 3G pitch: Cllr Leach asked if the new Chair of Langton Green Community Sports Association (LGCSA) had been made aware of SPC's advice to the previous Chair regarding submitting a successful planning application.
   Cllr Curry advised that he would be meeting with Mr Ponsford in the coming week and would take a hard-copy of the letter to make sure he was kept up to date.
- Cllr Cleaver asked for feedback from members on their preference for timing of
  planning committee meetings as this was the first meeting of the planning committee
  to be held during the daytime. Those present said they preferred daytime meetings
  however it was acknowledged that they do not work for those members who work
  during the daytime. It was agreed that going forward, the timing of meeting would be
  varied from month to month to suit everyone however an evening meeting would
  always be held if there was a large or contentious application on the agenda.
