MINUTES OF THE FULL COUNCIL MEETING HELD ON MONDAY, 7th APRIL 2014 at 7.30pm IN THE ELLIS ROOM, LANGTON GREEN VILLAGE HALL

MEMBERS OF THE PUBLIC: There were no other members of the public present

Cllr Mrs Jeffreys welcomed Peter Brown West Kent Neighbourhood Watch Co-ordinator who addressed the meeting – a copy of his report is attached to these minutes.

He said that Parish Councils engaging in Neighbourhood Watch with one Councillor responsible for security is a positive contribution to complying with section 17 of the Crime and Disorder Act 1998. Cllr Mrs Jeffreys asked Councillors to consider this and it will be on the agenda for the May Full Council meeting.

Cllr Mrs Jeffreys advised members of the recent death of former Parish Councillor Alan Passmore who served as a Councillor between 1991 and 2007. She said his lasting legacy is the superb standard of the footpaths in the parish and the band of footpath volunteers. Consideration will be given to an appropriate memorial.

14/085 DECLARATIONS OF PECUNIARY OR NON-PECUNIARY INTERESTS: Cllr Parker declared a non-pecuniary interest in 14/094 - Langton Green Rural Society's request to use the LGRG car park for the Fete on 5th July.

14/086 DECLARATIONS OF LOBBYING: Cllr Langridge declared that several members of the public have spoken to him about 14/096 – Community Right to Bid

14/087 MINUTES: It was **RESOLVED** that the Minutes of the Full Council Meeting held on **3rd March 2014** be approved as a correct record and signed by the Chairman.

14/088 BOROUGH AND COUNTY COUNCILLORS REPORTS: Cllr Davies said that the Langton Green Primary School planning application has been approved and he is going to contact Town and Country Housing about installing posts at the entrance to Winstone Scott Avenue and he may share the costs.

Cllr Stanyer reported that the owners of the cinema site have now signed a demolition agreement. He said that he has received several letters about the number of tall garden fences being erected.

Cllr Mrs Soyke advised that the proposed noise summit is not going ahead in April and another date will be arranged.

14/089 PUBLIC OPEN SESSION: There were no members of the public present.

14/090 FINANCE COMMITTEE – Report by Cllr Mrs Jeffreys in Cllr Owen's absence

It was **RESOLVED** to pay the invoices listed above, sign the cheques and authorise the BACS in Unity Trust Bank

14/092 HIGHWAYS: Cllr Mrs Podbury reported that a committee meeting was held on 24th March and the minutes have been circulated. She advised that there have been a number of accidents recently, one particularly serious one in Stockland Green Road on 28th March and another car overturned at the top of Groombridge Hill.

There was a recent incident where the bus driver dropped school children to walk on Etherington and Speldhurst Hills and there have been several reports of traffic speeding on the A264 by Langton Green Church.

i) It was **RESOLVED** to commission traffic surveys on Groombridge Hill and Ashurst Hill at a cost of approx. £550 each. Groombridge Hill will be done first.

14/093 COUNCILLOR VACANCY: The Clerk reported that the notices and boards advertising the casual vacancy will be up until 15th April. One person has expressed an interest so far. It was agreed that the interview panel will be Cllrs Mrs Jeffreys, Mrs Soyke and Milner.

14/094 LANGTON GREEN RURAL SOCIETY: It was **RESOLVED** to agree to the Rural Society's request to use the LGRG car park for the Fete on Saturday 5th July 2014.

14/095 FIRST WORLD WAR: Cllr Langridge reported that the working group held a meeting on 31st March and the notes have been circulated. Consideration will also be given to re-dedication of the War Memorials now that they have been refurbished.

14/096 COMMUNITY RIGHT TO BID: Cllr Langridge had circulated a proposal that the Council nominate land adjoining and owned by Treetops as a community asset. He said that the quarry was a haven of wildlife and lies within the conservation area. He said that there had been an application to develop the land which had been refused and was now going to appeal. Cllr Turner was against the proposal and after much discussion it was **RESOLVED** by a vote of 3 in favour, 2 against and 3 abstentions to nominate the disused quarry at Stonewall Park Road under the Community Right to Nominate and Bid for Assets of Community Value. The Clerk advised that this site may be ineligible for the same reasons that the previous application for The Green had been turned down (schedule 1 regulations, Localism Act 2011) and that it may set an undesired precedent. It was **RESOLVED** by a vote of 7 in favour and 1 against to commission an ecology survey at a maximum cost of £200.

14/097 ANNUAL PARISH ASSEMBLY: Cllr Mrs Jeffreys requested that as many Councillors as possible are available from 4pm on Monday 28th April to set up LGVH. It is proposed to collate the brochures on 23rd and 24th April and extra volunteers may be required. A Working Group is to be set up for the organisation of the APA in future years and new members will be required.

14/098 CHAIRMAN'S REPORT: Cllr Mrs Jeffrey's report of the Parish Chairmen's meeting held on 11th March has been circulated. She suggested that the seminars for home-based businesses and the appeal for a rural cyclist to join the cycle campaign be included in village magazines/local newsletters.

14/099 COMMITTEE REPORTS:

i) **Governance** – In Cllr Pendleton's absence Cllr Mrs Jeffreys reported that a Committee meeting was held on 26th March and the minutes have been circulated.

- ii) **Planning** Cllr Langridge reported that a Committee meeting was held on 10th March and that the minutes have been circulated. The next Committee meeting will be held on 8th April.
- iii) **Amenities** Cllr Milner reported that a Committee meeting was held on 17th March and the minutes have been circulated. It was **RESOLVED** to adopt the Terms of Reference following the annual review. It was **RESOLVED** to accept the Committee's recommendation that a new double notice board is purchased for Speldhurst Chapel and the existing single notice board moved to a location in Ashurst.

- iv) Air Traffic It was RESOLVED to join the High Weald Parish Councils Aviation Action Group (HWPCAAG) to campaign against aircraft noise, low flying aircraft and night flights on behalf of the electors of the parish and to oppose the proposed second runway at Gatwick by a vote of 7 in favour and 1 against. Cllr Mrs Soyke explained that should SPC disagree with any opinion proposed by the Action Group it will have the option to opt out.
- v) **Footpaths** Cllr Milner reported that contact has now been made with Dr Powell and that KCC will be mending the handrail bridge in Shadwell Wood.
- vi) **Broadband** There was nothing to report.
- vii) **KALC** There was nothing to report.
- viii) **Parish Plan Working Group** Cllr Turner reported that James Bowdidge has been appointed Chairman of the working group and the next meeting will be held on 15th April. Cllrs Mrs Podbury and Langridge are working on a budget which will be submitted to the Council for approval.
- ix) **Environment Working Group** It was **RESOLVED** to enter Speldhurst village (two categories Furzefield Avenue and Shadwell Wood) in the Kent Men of the Trees Competition at a cost of £20.
