

Local Government for Langton Green, Speldhurst, Ashurst and Old Groombridge

Minutes of a Planning Committee Meeting held on Wednesday 7 February at 7.30pm in the Palmer Room, Langton Green Village Hall

MEMBERS OF THE PUBLIC PRESENT: There were 8 members of the public present.

- 1. To enquire if anyone present intends to film, photograph and/or record the meeting: No- one present intended to film, photograph and/or record the meeting.
- 2. To receive and approve apologies and reasons for absence: There were none.
- 3. Disclosure of Interests: There were none.
- 4. Declarations of Lobbying: All members of the Planning Committee had been lobbied regarding application 17/04294/FULL Land Adjacent, Keepers Cottage, Burnt House Lane, Langton Green, Royal Tunbridge Wells, Kent TN3 OJR.
- **5. Minutes: RESOLVED** that the minutes of the Planning Committee meeting held on **10th January 2017** be approved as a correct record and signed by the Chairman.
- **6. Matters Arising:** The Assistant Clerk said that the details for application no. 17/02743/FULL -Farm Buildings Near Scriventon House Stockland Green had been updated. It was **RESOLVED** to re-comment on the application at the next Planning meeting.
- 7. Public Open Session Peter Hurst of Burnt House spoke first on behalf of the Burnt House Lane Residents Group. He circulated a detailed letter of objection including photographs. In summary, Mr Hurst said that they have no issue with the Woodland Management Plan or the ability of Tilhill Forestry to carry it out. They do however have concerns over primarily the use of large vehicles along a narrow country lane which residents park their cars down; the disruption in terms of the noise produced; the visual effect upon the landscape; the gas and water mains running across the entrance to the proposed site and residents' loss of privacy.
 - They are concerned about the wagons blocking Burnt House Lane before then going out onto the Speldhurst/Langton Road which is a blind bend with inadequate sight lines.

Jeremy Salmon, a resident, spoke next. He queried whether the entrance to the woods off Lower Green Road or through an existing access near to the Anchorage could be used.

Mr Percival, a resident whose land backs directly onto the site said he is objecting to the use of Burnt House Lane primarily on behalf of public safety.

Sean Ramsay of Keepers Cottage, who is wheelchair bound, said that he moved to the area for peace and quiet however this would be disrupted should the application be allowed. Additionally, his drive will be blocked by the wagons reversing into the bell mouth.

Stephen Quest a resident added his concerns about the safety of the road – it is a very dangerous corner already which is liable to accidents – the loading bay would only make it worse.

Hugh Davies of Tilhill spoke next. He said that the main reason why that access route was chosen is because of ownership of land. He acknowledges that there are historic access points. He advised that the lorries are custom built for accessing tight areas. They could try and avoid rush hours and work with local residents when carrying out their activities. He said that he will go back to the owner of the woods to consider different access options. He circulated a photograph of an existing loading bay elsewhere. It was noted that it had taken 4 years for the grass to have grown over the type 1 in the picture.

Councillors asked if Tilhill had looked at the Lower Green Road option. Mr Davies said that it would mean taking out wood banks which would cause more damage and also concern to residents in that road.

Cllr Mrs Price enquired about the vehicles used. Mr Davies then circulated a photograph. A forestry all-terrain vehicle would be stored in the woodland all year round and would be used to move the logs within the wood, additionally a forwarder and a harvester which breaks the wood into 5m lengths would be used.

Cllr Mrs Soyke enquired about the length of the vehicles to which Mr Davies replied 22m which is the full length of the lorry plus a trailer. It can be disconnected but that would involve more trips.

8. Planning appeals - 17/01607/OUT

Garages Adjacent to Pax Cottage, Stockland Green Road, Speldhurst Outline (Layout, landscaping) – Proposed demolition of three garages and erection of a single storey detached dwelling.

9. Planning applications for discussion and decision:

17/04294/FULL

Location: Land Adjacent, Keepers Cottage, Burnt House Lane, Langton Green, Royal Tunbridge Wells, Kent TN3 0JR

Proposal: Construction of 4m wide by 25m long loading bay with a 10m bell mouth entrance to Shadwell and Sprouds Wood, including replanting hedgerow, replacement gate and erection of fencing.

Decision: We object on the grounds of safety, both within Burnt House Lane, for other road users and also particularly at the junction with the Speldhurst/Langton Road with 22m vehicles emerging on a blind bend on a 40mph road which could potentially cause a traffic hazard. We are aware of several serious accidents in the vicinity recently. We are concerned that there could be inadequate width given the parked cars in front of the cottages and the lack of passing places. We note there is a sign indicating no heavy vehicles at

the entrance to Burnt House Lane. We are concerned about the noise and disturbance to neighbouring properties. We note there may be an issue with a gas main which passes across the entrance to the site.

Should the application be permitted, we would have the following suggestions: -

- 1. Operations should be restricted to non-peak hours.
- 2. When the vehicles are in operation, adequate warning signs or preferably traffic controls should be implemented on the Langton/Speldhurst Road.
