# Minutes of a Planning Committee Meeting held in the Committee Room, Langton Green Village Hall on Tuesday 5<sup>th</sup> April 2011 at 7.30pm

MEMBERS OF THE PUBLIC PRESENT There were no members of the public present

1. Apologies and Reasons for Absence: Cllr Mrs Paulson-Ellis (prior engagement), Cllr Brown (prior engagement), Cllr Milner (prior engagement) and Cllr Wheeler (prior engagement)

#### 2. Declarations of Interest:

All Committee members and Asst Clerk **KCC/TW/0081/2011** and **KCC/TW/0119/2011** Speldhurst Parish Council has given a grant to Speldhurst CEP School for both these proposals – Personal and Prejudicial.

- 3. Declarations of Lobbying: There were none.
- 4. The Minutes of 14<sup>th</sup> March 2011 were signed as a correct record.

#### 5. Matters Arising:

Cllr Mrs Hull reported that she has been in contact with Darren Hood of Kent Highway Services regarding the dead Acacia tree on the verge outside her house. He has confirmed that KHS will fell the dead tree but that he does not think the sapling will transplant as a replacement and in addition KHS have no budget for trees at present. However he advised her of a Government initiative 'The Big Tree Plant' which has funds available for trees for parish land. A KHS services check will still be required before any trees are planted. **Cllr Mrs Hull to find details of 'The Big Tree Plant'**.

The Asst Clerk reported that she has a response from TWBC regarding the street name for the development of the Old Police House site in Langton Green. 'The Langtons' is purely a marketing name for the development. The access to the houses is not a street so will not have a street name. The properties are all to be given names and the addresses will be e.g. Snowdrop House, Speldhurst Road, Langton Green.

34 Asher Reeds, Langton Green – the Applicant has lodged a planning appeal. The assistant clerk to write to the Planning Inspectorate confirming that Speldhurst Parish Council supports TWBC's decision to refuse planning permission.

The assistant clerk is to pursue the matter of the driveway wall at Furzewood, Barden Road, Speldhurst protruding onto the highway.

Cllr Mrs Podbury advised that there is likely to be a planning application in the near future in respect of the Southern Water sewage works in Broom Lane Langton Green. **The assistant clerk to ascertain whether this will be dealt with be Wealden District Council or East Sussex County Council and if Speldhurst Parish Council will be consulted.** Cllr Mrs Podbury also commented that there are still smells from the sewage works. If residents contact the Parish Council they should be advised to contact Southern Water direct with full details.

Location: The Gardens, Barden Road, Speldhurst, Royal Tunbridge Wells Proposal: Change of use of part of land to burial ground Decision: Recommend approval Comment: The existing Churchyard is nearly full and villagers should be able to be buried in the village Churchyard if that is their wish

## TW/11/00565/FUL/GM2

Location: 18 and Land Rear of 16 Northfields, Speldhurst, Royal Tunbridge Wells Proposal: Construction of single-storey bungalow and car parking space to rear garden of Nos. 16 and 18, together with relocating one car parking space to No. 18 Decision: Recommend refusal

Comment: The proposed property will be cramped and overbearing and there will be parking issues. The roof height for a bungalow appears excessive and if TWBC is minded to give consent we would ask that a condition is placed that further accommodation in the roof space will not be permitted now or in the future.
