Proposal: Trees in a Conservation Area Notification: Oak – Remove.

Decision: Remain neutral, leave to Tree Officer.

24/03018/TCA – The Old Butchers, Bird in Hand Street, Groombridge

Proposal: Trees in a Conservation Area Notification: Ash – Fell; 2 No. Yew Trees – Pollard

by 30-50%, Sycamore – pollard by 30-50%.

Decision: Although it's a matter for the Tree Officer, we would like to see more

information about the Ash tree and the reasons for felling.

Proposal: Rear extensions, replacement of tile hanging with render relocation of entrance

porch, and conversion of garage.

Decision: Remain neutral, leave to Planning Officer. Please note that the applicant is a

Speldhurst Parish Council Councillor.

24/02853/FULL – 14 Holmewood Ridge, Langton Green

Proposal: Retrospective installation of 92 solar panels in the garden.

Decision: Remain neutral, leave to Planning Officer.

24/02831/FULL - Sherwood, Furzefield Avenue, Speldhurst

Proposal: Single storey infill to rear of existing dwelling and raised access steps to rear

garden.

Decision: Remain neutral, leave to Planning Officer.

24/02832/TPO – 15 Roopers, Speldhurst

Proposal: Trees: 5 No. Fir (G3) – reduce height by 25%; Fir (T26) – Reduce height by 25%,

Fir (T27) - Reduce by 25%.

Decision: Remain neutral, leave to Tree Officer.

24/02835/TCA Burrswood Lodge, Bird in Hand Street, Groombridge

Proposal: Trees in a Conservation Area Notification: 2 No. Yew, 3 No. Conifers, 1 No.

Sycamore and several dead trees of Unknown Species – Fell.

Decision: Remain neutral, leave to Tree Officer. The application has insufficient supporting detail for example the number and type of trees. We are surprised this

application passed the technical validation.

24/02804/FULL – Long Acre, Ferbies, Speldhurst

Proposal: Two-Storey extension, conservatory and garage conversion with additional

changes to fenestration.

Decision: Remain neutral, leave to Planning Officer.

24/02795/LBC - Burrswood Lodge, Bird in Hand Street, Groombridge

Proposal: Listed Building Consent – Repair of exterior walls and chimney, Conversion of garage, replacement roof tiles, removal of dormer windows, extension of room, replacement of internal doors and windows and flat roof, erection of porch and internal alterations within kitchen, shower room, hallway, garage and bedroom.

Decision: We support this application but highlight the potential removal of the dormer windows to the Heritage Officer to whom we defer.

24/02794/FULL – Burrswood Lodge, Bird in Hand Street, Groombridge

Proposal: Repair of exterior walls and chimney, Conversion of garage, replacement roof tiles, removal of dormer windows, extension of room, replacement of internal doors and windows and flat roof, erection of porch and internal alterations within kitchen, shower room, hallway, garage and bedroom.

Decision: We support this application but highlight the potential removal of the dormer windows to the Heritage Officer to whom we defer.

24/02789/FULL - 43 Holmewood Ridge, Langton Green

Proposal: Erection of single-storey garden building. **Decision:** Remain neutral, leave to Planning Officer.

24/02790/FULL - Tamerton House, Furzefield Avenue, Speldhurst

Proposal: Erection of a garden Room.

Decision: Remain neutral, leave to Planning Officer. We would like to make sure that

there is no impact on the historic woodland.

24/02763/FULL – Finchcocks Manor, Fordcombe Road, Fordcombe

Proposal: Creation of new sand school and association ecological improvements.

Decision: Remain neutral, leave to Planning Officer.

24/02684/FULL – Perugia, Ewehurst Lane, Speldhurst

Proposal: Creation of detached single storey annexe building to replace existing outbuildings and double garage.

Decision: We remain neutral and leave to Planning Officer however would request a condition is put in place on any permissions that the annexe remains deferential to the main property.

24/01631/LBC - 7 The Walks, The Green, Groombridge

Proposal: Listed Building Consent – Proposed installation of wood burner and creation of en-suite (works commenced).

Decision: Remain neutral, leave to Conservation Officer.
