Minutes of a Planning Committee Meeting held on Tuesday 10th July 2018 at 7.30pm in the Palmer Room, Langton Green Village Hall, Langton Green Recreation Ground

MEMBERS OF THE PUBLIC PRESENT: There was one member of the public present.

- 1. **To enquire if anyone present intends to film, photograph and/or record the meeting:** No- one present intended to film, photograph and/or record the meeting.
- 2. **To receive and approve apologies and reasons for absence**: apologies were received from Councillors Mrs Jeffreys (holiday), Allen (work) and Mrs Soyke (prior engagement).
- 3. **Disclosure of Interests**: there were none.

Declarations of Lobbying: Cllr Rowe advised that he had held a conversation with a resident regarding 18/01233/FULL: Sandown, Northfields, Speldhurst, Tunbridge Wells, Kent TN3 OPL.

- 4. **Minutes: RESOLVED** that the minutes of the Planning Committee meeting held on 20th June 2018 be approved as a correct record and signed by the Chairman.
- 5. **Matters Arising:** there were none.
- 6. **Draft High Weald Area of Outstanding Natural Beauty Management Plan 2019-2024 Public Consultation:** Councillors discussed this consultation and agreed the following response: SPC supports the Draft High Weald Area of Outstanding Natural Beauty Management Plan 2019-224 Public Consultation however we are concerned whether sufficient weight will be given to the objectives by the local planning authority given the current pressure for housing development.
- 7. Public Open Session: There was one member of public present who was representing his neighbours regarding the appeal for Peacock Farm. He said that Peacock Farm is operating a commercial business without planning permission. They have 30 storage containers on site which are being used as lock-ups. There has been a drastic increase in traffic large commercial lorries are now often speeding down a narrow residential country lane seven days a week from early in the morning until late at night. The noise, dust and vibration, particularly in relation to the scaffolding business being run from the farm is spoiling the amenity of what used to be a

quiet area in the Greenbelt and AONB.

Location: Peacock Farm, Lower Green Road, Royal Tunbridge Wells, Kent

Proposal: Appeal against Enforcement Notices: JS/T010204 – Without planning permission the change of use of land from agricultural to a mixed use of agricultural and the storage of motor vehicles and motor vehicle parts, the placing of storage containers, the storage of scaffolding and aggregates materials.

Councillors discussed this appeal and it was agreed the Inspector would be written to with the following comments:

We strongly support the enforcement notices M2270/C/17/3188653 & 3188654 — Without planning permission the change of use of land from agricultural to a mixed use of agricultural and the storage of motor vehicles and motor vehicle parts, the placing of storage containers, the storage of scaffolding and aggregates materials and consider it should be complied with for the following reasons:-

- 1. Inappropriate unauthorised development in the Greenbelt and AONB.
- 2. We have received representations of loss of amenity for neighbouring properties through noise, dust, vibration and pollution throughout the extended day and at anti-social hours.

Proposal: Demolition of conservatory and erection single storey rear extension and stainless-

steel chimney.

Decision: Remain neutral – leave to Planning Officer.

Location: 10 Roopers, Speldhurst, Royal Tunbridge Wells, Kent TN3 0QL

Proposal: Trees: Robinia (T1) – Fell

Decision: Remain neutral – we would wish the tree to be replaced.

Proposal: Demolition of single storey rear glazed extension, replacement with an enlarged single

storey extension, roof extensions and side extension. Decision: Remain neutral – leave to Planning Officer.

Proposal: Conversion of and extension to existing detached garage to form a garden studio space

Proposal: Variation of Condition 2 (Approved Plans), condition 3 (External Materials), condition 8 (landscaping) and condition 9 (tree protection) of 17/02574/FULL (Demolition of existing dwelling and creation of a replacement dwelling) - Changes to elevations, chimney stack design, materials and fenestration; submission of landscaping and external material details.

Decision: Remain neutral – leave to Planning Officer.

Proposal: Demolition of existing car port, garage and shed and erection of a single storey side

extension.
