# Minutes of a Planning Committee Meeting held on Monday 13<sup>th</sup> April 2015 at <u>6.30pm</u> in the Parish Council Office, Langton Green Recreation Ground

MEMBERS OF THE PUBLIC PRESENT: There were two members of the public present.

- 5. Minutes: RESOLVED that the minutes of the Planning Committee meeting held on 24<sup>th</sup> March 2015 be approved as a correct record and signed by the Chairman.

7. Public Open Session – the meeting will be adjourned to give members of the public an opportunity to raise with the Committee any items of interest or concern. If members of the public are attending regarding a specific planning application on this agenda the Committee Chairman may bring this application forward under item 8. Below. The public open sessions may be limited to a time to be determined.

There were two members of the public present in respect of 15/501700. It was **RESOLVED** to bring this application forward on the agenda and the members of the public present spoke and made the following comments:

- This application is again part retrospective and piecemeal, is not only for estate maintenance and will open the 'floodgates' for large themed events.
- The link crosses the public right of way and the gates do not safeguard pedestrians. It was being used over Easter by the former Father Christmas World train.
- Concern and suspicion from neighbours that Mill Farm has now been renamed Sunny Bank Farm.
- The site is within an Area of Outstanding Natural Beauty and the Metropolitan Green Belt and is considered a priority wildlife habitat.
- An unauthorised rear access has been created via Cobblestone Mews.
- There are rumours of proposals for a young person's driving school on the estate.

The Assistant Clerk reported that Tunbridge Wells Borough Council (TWBC) have confirmed that all current applications relating to Salomons Estate and Mill Farm will be called-in for consideration by TWBC Planning Committee.

The Committee discussed the application and made the following recommendation and comments:

## 15/501700/FULL

Location: Mill Farm, Broomhill Road, Royal Tunbridge Wells, TN3 0TD

Proposal: Creation of track linking Salomons Estate and Mill Farm, including erection of gates and

boundary fencing (part completed)
Decision: Recommend refusal

Comments: As per our previous comments we are greatly concerned that this is yet another retrospective application in respect of the Salomons Estate and this piecemeal approach to what is clearly a comprehensive development is clearly unacceptable. We believe that the three neighbouring local councils; Southborough Town Council, Speldhurst Parish Council and Rusthall Parish Council should all be consulted on every application relating to Salomons Estate and Mill Farm at the same time.

We would ask that this application is called-in to be considered by Tunbridge Wells Borough Council Planning Committee.

We would also ask that the Public Rights of Way Officer is consulted on this application given our considerable concerns about public safety as a result of this link crossing the Public Right of Way. Recent commercial activity witnessed by residents and Councillors supports this concern.

The development and use of this link is totally unsuitable for this location. It is within an Area of Outstanding Natural Beauty and the Metropolitan Green Belt.

There would be an adverse impact on protected wildlife species and overall biodiversity as recognised by TWBC Biodiversity Officer David Scully.

We also have concerns about potential noise and light pollution.
