

# Authorisation for the Provision or Sale of Alcohol

## Authorisation for the Provision or sale of alcohol in accordance with the Licensing Act 2003

When agreed by the hirer as part of a hire agreement, this form grants the applicant authorisation to provide or sell alcohol at **The Pavilion, Langton Green Recreation Ground, Speldhurst Road, Langton Green** on the date and time as specified in the hire agreement.

The applicant is legally obliged to comply with the Licensing Act 2003 Mandatory Conditions 2010 in relation to the supply of alcohol.

In accordance with the Licensing Act 2003 mandatory Conditions 2010, the responsible person (the applicant in this case) shall ensure that the following drinks are available in the following measures:

Beer or cider:	½ pint
Gin, rum, vodka or whisky:	25ml or 35ml
Still wine in a glass:	125ml

Customers or guests are to be made aware of the availability of these measures.

The following responsibilities apply to all people involved in the provision or sale of alcohol:

- No alcohol is to be sold or delivered to anyone under 18 years of age. A PASS proof of age card, photo driving licence or passport can be accepted as proof of age. A soft or non-alcoholic drink may be provided to someone under 18 years old but not a low-alcohol drink. An adult may purchase or procure wine, beer or cider for someone aged 16 or over only for drinking with a table meal taken with an adult.
- No alcohol is to be sold to anyone who appears to be drunk or who is buying or procuring alcohol for someone who appears to be drunk. Slurred speech, clumsy movements and loud or aggressive behaviour are signs of drunkenness, but not exclusively.
- No alcohol is to be sold or provided after the times stated above.
- Drunk and disorderly behaviour is not permitted. It is the responsibility of the applicant to ensure that such behaviour does not occur. (If someone refuses to leave when asked politely to do so, the applicant should warn them that they are committing a criminal offence. If they still refuse to leave then please call the police for assistance: do not attempt to remove them, for safety reasons.)
- Smuggled goods must not be sold, provided or kept on the premises.
- Every sale or provision of alcohol by a person aged under 18 must be specifically authorised by a member of the Pavilion Management Committee or the following adult(s) who have been authorised by the Pavilion Management Committee to give such approval:

- If the applicant suspects that anyone is taking or supplying drugs, s/he must inform the police.

These responsibilities apply where the sale or provision of alcohol is carried out under the authority of a temporary Event Notice as well as under a Premises Licence.

Note that the maximum penalty for breaking the law in these respects is a fine of £20,000 or 6 months in jail. Those attempting to purchase or procure alcohol who are under 18, or for someone under 18, or who are drunk or buying or procuring for a drunk are also guilty of an offence.

By completing the online hire agreement and booking the Pavilion, the applicant hereby agrees to comply with these requirements for the sale of alcohol.
