Draft Minutes of a Planning Committee Meeting held at 7.30pm on Monday 16th August 2021 in the Palmer Room, Langton Green Village Hall, Langton Green

Proposal: Trees: A1 (Limes x 4, Oak, Beech) Reduce to 2 metres below old pruning cuts and

reduce lateral branches by 5-6 metres

Proposal: Single storey rear extension, loft conversion with dormer and internal alterations

Decision: Remain neutral, leave to Planning Officer

Proposal: Demolition of garage and erection of a single storey side/front extension

Decision: Remain neutral, leave to Planning Officer

Proposal: Single storey pitched roof rear and side extensions

Decision: Remain neutral, leave to Planning Officer

Proposal: Trees: Yew (T1) – Reduce by 2m **Decision:** Remain neutral, leave to Tree Officer

21/02252/TPO – 3 Hazelbank, Langton Green

Proposal: Trees: Cedar (T1) – Remove 2 dead stumps over the highway, sever ivy, lift crown to 5.5 metres over the highway, cutting small branches only; Oak (T2) – Remove major dead and diseased wood, 25mm in diameter and over, lift crown to 5.5 metres over the highway, reduce 4 over extended low limbs by 2 to 3 metres to leave the lower crown more consistent with the upper crown and top

Decision: Remain neutral, leave to Tree Officer

21/02195/FULL – The Drift, Groombridge Road, Groombridge

Proposal: Proposed erection of a detached outbuilding to be utilised as a gym and home office

Decision: Objection. The reason for the objection is that, when considered with planning application 21/02189/FULL, the combined effect will be overdevelopment and urbanisation of this site which is both within the Green Belt and Area of Outstanding Natural Beauty.

21/02189/FULL - The Drift, Groombridge Road, Groombridge

Proposal: Detached pool building with associated changing rooms

Decision: Objection. The reason for the objection is that, when considered with planning application 21/02195/FULL, the combined effect will be overdevelopment and urbanisation of this site which is both within the Green Belt and Area of Outstanding Natural Beauty.

21/02166/FULL – 8 Little Mallet, Langton Green

Proposal: Conversion of part of garage to living accommodation; single storey front extension

Decision: Objection. We note the concerns raised on the previous application which have led us to reconsider our view. We do not believe the revised plans have adequately overcome the original objections.

21/02547/LBC – Lower Church Farmhouse, Speldhurst Hill, Speldhurst

Proposal: Listed Building Consent – To fill in a garden area between two sections of the

house with a new kitchen extension

Decision: Remain neutral, leave to Conservation Officer

- 10. **Recreation Ground, Southwood Road, Rusthall application 21/00068/FULL:** A joint letter from Speldhurst Parish Council and Rusthall Parish Council had been sent to Greg Clark MP expressing disappointment at his response to this application.

 - Walnut Cottage, Langton Road, Langton Green: the fencing had been reported to TWBC Enforcement who were investigating. The maximum height permitted is 1m.
