- **5. Matters Arising:** The clerk confirmed that the Post Office has amended the postcode of Colbran Way on the Middlefield development. The new postcode is TN4 8DB instead of TN3 0BF and TWBC have informed the developer.

Cllr Mrs Podbury said that there were still problems with the new test site of TWBC's Public Access and she had not been able to gain access to it.
