8. Planning Applications for consideration

#### 25/02142/TPO - 3- 9 Gibbetts Langton Green

**Proposal:** TREES: 5 no. SYCAMORE (T1-T5) & 4 no. OAK (T6-T9) - Reduce canopy by 30% (3m) to suitable growth points, remove major deadwood, crown lift to 3m over the garden area and 5m over the adjacent highway, crown thin by (10%) by removing crossing and rubbing branches and remove basal growth

Decision: Remain neutral, leave to Tree Officer.

# 25/02050/LBC- Holmewood House School, Barrow Lane, Langton Green.

**Proposal:** Listed Building Consent. Replacement of top and bottom sash windows to first floor.

**Decision:** No objection - very pleased with choice of material and support the conservation officers' comments as they are in support of using appropriate materials.

### 25/02049/Full- Holmewood House School, Barrow Lane, Langton Green

**Proposal:** Listed. Replacement of top and bottom sash windows to first floor (Partretrospective).

## 25/02172/TPO -Broom House, Broom Park, Langton Green

Proposal: TREES: 2 no. BEECH (G10) - Prune by up to 3.5m.

**Decision:** Remain neutral, leave to Tree Officer.

# 25/01999/BC – 3 Stone Cottages, Groombridge Hill, Groombridge

Proposal: (works completed) Replacement of stable door to UPVC.

**Decision:** Request to retain the UPVC. We agree with Conservation Officers' comments and would like to see the reinstatement of the timber section of the door.

### 25/02232/TPO - 5 Roopers, Speldhurst

Proposal: TREES: OAK (T1) - Thin by 20% and prune back by 3-4m. Remove sucker growth

on stem.

**Decision:** Remain neutral, leave to Tree Officer.

## 25/02220/TPO – Land at Roopers, Opposite Birch Cottage, Speldhurst

Proposal: TREES: HAZEL (T1 within A1) - Remove small stems around the stool, remove

growth over the road; LIME (T2 within A1) - Remove low level growth.

**Decision:** Remain neutral, leave to Tree Officer.

# 25/02128/FULL – Scriventon House, Franks Hollow Road, Speldhurst

**Proposal -** Variation of Condition 2 of Planning Permission 24/01278/FULL - Building B: Amendments to design of building including alterations to external fenestration; installation of a chimney; alterations to ground level; repositioning of rooflights; turning head extension.

**Decision:** Remain neutral, leave to Planning Officer.

#### 25/01761/FULL - Little Court Lodge, Penshurst Road, Speldhurst

**Proposal:** Front single-storey extension.

**Proposal:** TREES: HORSE CHESTNUT (T1) - Reduce the overall canopy by 4-5m.

## 25/02115/FULL- 4 Widbury, Langton Green

**Proposal:** Single-story rear extension.

**Decision**: Remain neutral, leave to Planning Officer.

## 25/02159/TPO - Gidleigh Broom Park Langton Green

**Proposal:** TREES: ENGLISH OAK (T1) - Crown Reduction; height and spread reduction by up

to 3m.
