# MINUTES OF THE FULL COUNCIL MEETING HELD ON MONDAY, 5<sup>th</sup> SEPTEMBER 2011 at 7.30pm IN THE COMMITTEE ROOM, LANGTON GREEN VILLAGE HALL

#### 11/150 MINUTES:

The Minutes of the Full Council Meeting held on 1<sup>st</sup> **August 2011**, having previously been forwarded to Members, were approved and signed.

## 11/151 PUBLIC OPEN SESSION:

The meeting was adjourned.

County Councillor John Davies reported that he now has a Highways Manager, Earl Bourner, dealing with his area. The residents of Stone Cross spoke about the numerous accidents and incidents at Stone Cross and asked what could be done to improve this section of the A264 before further serious crashes resulted in a fatality. The Clerk advised that there is a proposal to reduce the speed limit on the whole section of road from Langton Green to Ashurst to 50mph, however it was recognised that this area warranted more attention and a lower speed limit. Both Cllr Ringrose and Cllr Mrs Hull expressed the opinion that the speed limit at Stone Cross should be 30mph. They were advised that there was to be a Highways Committee meeting on 16<sup>th</sup> September and Kent Highway Services (KHS) would be attending and the matter would be on the Agenda. They were advised to report all incidents to the Clerk and give a history of events to-date. Cllr Pendleton also suggested raising the issues at Stone Cross with Greg Clark MP when he is at Ashurst on 23<sup>rd</sup> September.

The meeting was re-opened.

## 11/152 FINANCE COMMITTEE - Report by Clir Mrs Jeffreys

- i) Cllr Mrs Jeffreys reported that there have been no meetings or minutes circulated since the last Full Council meeting and that the next Committee meeting will be held on 26<sup>th</sup> September.
- ii) Cllr Mrs Jeffreys reported that there had been six email decisions by the Finance Committee. It was agreed to send Councillors and the Clerks on various courses in September and October at a total cost of £849 and to spend £4 at the Land Registry to find out who owned a house in Speldhurst. It was agreed to spend £165 to replace a damaged kerb on the new islands at The Green, to control the weeds at Langton Green War Memorial at a cost of £50 and to have a survey done of the Copper Beech tree on Parish Council land at Langton Green at a cost of £375 plus VAT. The Clerk's overtime of seven hours was approved.
- iii) After discussion it was unanimously **AGREED** to authorise expenditure on the Broadband surveys and posters up to a maximum of £650 pending agreement that a written survey was necessary see 11/158 below
- iv) Christopher Blyth, Treasurer of St Martin's Church, Ashurst referred to his email to the Clerk of 6<sup>th</sup> August with a request of a grant towards building works and with Peter Soyke gave more details. After discussion it was proposed by Cllr Pendleton that a letter of comfort be issued offering a maximum grant of £5,000. An amendment to the proposal was proposed by Cllr Mrs Hull who did not support exceeding the amount that was in the budget which was £4,500. Cllrs voted on the amendment which was passed by six votes to four. It was then **AGREED** by eight votes with two abstentions that a letter of comfort be issued for £4,500.00.
- v) It was **AGREED** to adopt the 'Grant Awarding Guidelines' which would be reviewed after one year, however, a standardized application form would be written if it was considered necessary.
- vi) Cllr Mrs Jeffreys proposed that the loan of £3,250 to LGCT, which will be to 30<sup>th</sup> June 2013, is at 0% interest. This was unanimously **AGREED**. Cllr Owen asked to see the original quotations for the building works. **The Clerk to ask Trevor Palmer to bring them to the next site meeting**.
- vii) After much discussion it was **AGREED** by nine votes, with one abstention, that £50,000 be invested for one year with a main UK High Street Bank with the final decision to be made by the Finance Committee.

## 11/154 HIGHWAYS REPORT:

Cllr Mrs Podbury referred to her written report on the meeting held on 4<sup>th</sup> August with Jonathan Dean the new KHS Steward. A Committee meeting is to be held on 16<sup>th</sup> September at which the KHS Steward will be present.

#### 11/155 ENHANCEMENT OF THE LAND OUTSIDE THE OLD WATSON HALL:

The Clerk reported that the posts have been installed and that instructions had been given to replace the damaged kerbstone. Cllr Hemming considered that an accident would happen because cars were unsighted and were being forced together by parked cars. The Clerk advised that KHS have stated that they would monitor the situation before installing double yellow lines. Councillors decided that KHS should be lobbied now for their installation given the likelihood of an accident. **Clerk to write to KHS.** 

#### 2249 PARISH COUNCIL OFFICE:

Cllr Mrs Jeffreys referred to her written report on the progress of the building works and confirmed that completion is scheduled for the week commencing 24<sup>th</sup> October.

## 11/156 LOCAL SCHOOLS:

It was reported that neither Langton Green nor Speldhurst Primary School required the bicycle shelter from the LGCT and that it might be more appropriate for a Secondary School. **The Clerk will ask Paul Harvey whether Speldhurst Village Hall want the bicycle racks**. The new classrooms have been installed at Langton Green Primary School. Cllr Pendleton reported that three girls from Groombridge living on the Kent side of the border had gained places at TWGGS following appeals, but none of the children from East Sussex won their appeal. The barrier was still to be installed by KHS at Speldhurst School.

## 11/157 LGRG SPORTS PAVILION:

## (This item was discussed on the evening at an earlier juncture – after 11/152vi)

Guy Lambert of Langton Green Sports Club spoke in detail of the LGSC and the Club's wishes to improve the pavilion and its facilities. He described the grants available from the Football Foundation advising that they were only available if the applicant has a minimum tenure of a twenty five year lease on the site. He said that the Football Foundation offers a free legal service for drawing up appropriate leases and that there may be other funding available depending on the terms of the lease.

After much deliberation and many questions Cllr Mrs Jeffreys proposed that a vote be taken on approval in principle to lease land to the LGSC to match the footprint of a new pavilion. This would be subject to the negotiation of a satisfactory lease. This was unanimously **AGREED.** 

The Clerk was asked to contact LGCT to see if a copy of the lease of the Village Hall could be given to LGSC to use as a model for drafting the agreement.

## **11/158 BROADBAND:**

Cllr Woodward reported that the working party had met and there had been considerable email "traffic" on the subject. The working party had decided that a paper survey was the only way to catch all users and potential users. Parish Vision volunteers were going to be asked to help with distribution and collection. He said that one survey would be used for residential and business users and spoke of the reasons for using a paper survey. Councillors **AGREED** that it was the best way to communicate to residents of the Parish. Cllr Owen reminded members of the data protection issues arising from data collected as part of the survey.

## 11/159 SHOPS IN THE PARISH:

Cllr Pendleton advised that a new Flower Shop is opening in the Black and White Shop on Groombridge Hill.

**11/160 QUEEN'S DIAMOND JUBILEE:** Cllr Mrs Jeffreys reported that this is on the Agenda to be discussed at the Parish Council Chairman's meeting on 6<sup>th</sup> September and therefore it should be deferred until the October meeting when more information would be available.

11/161 ANNUAL PARISH MEETING: The new format proposed by Cllr Mrs Jeffreys was AGREED. A new Working Party consisting of Cllr Mrs Jeffreys, Cllr Mrs Podbury and Cllr Langridge was formed.
